A. Water Superintendent Update: We have had a few sewer issues that have been taken care of. Our water treatment plant is running smoothly. Matt is looking into purchasing a semi load of toted brine that cuts the cost way down and will bring the proposal to the board in September. We did another round of cleanup of storm debris around town and caught up on the mowing. Our hardness has been ranging between 148 and 160 on the high-end, but that's much better than the 220 ppm it used to run before the new treatment plant. We flushed 10 fire hydrants to keep improving the quality of water for the Town of Welch.

B. Presentation and discussion of past due water bills and meter repairs. 9 meters were locked off due to non-payment of water usage, 7 paid the reconnect fee and past due bill in full, 2 remain locked off.
